- 2.3 Installation of partial road closure signs and barricades be in accordance with AS 1742.3:2009 Traffic Control for Works on Roads and the Transport for NSW Traffic Control at Work Sites Manual.
- 2.4 Emergency services be notified of the partial road closures and access for emergency service vehicles be always permitted.
- 2.5 The Applicant shall take necessary steps to minimise disruption to traffic flow along Newleaf Parade and the surrounding streets.
- 2.6 The detour signage be installed in accordance with the authorised Traffic Control Plans.
- 2.7 Access to residences is maintained during the period of the works.
- 3. A public liability insurance of at least ten million dollars (\$10,000,000.00) be submitted to Council.
- 4. The Project Manager, JK Williams be notified of the Committee's decision.
